

LAKESIDE PARK-CRESTVIEW HILLS POLICE AUTHORITY BOARD

Regular Meeting – October 17, 2022

CALL TO ORDER: The regular meeting of the Lakeside Park-Crestview Hills Police Authority Board was called to order at 1733 hrs by Vice Chairman Paul Markgraf.

ATTENDANCE: Those in attendance were Dave Kramer, Paul Markgraf, Mark Lehman and Brian Waite. Bill Dorsey was absent. Also in attendance were Col. Schutte, Lt. Colonel Degenhardt, Sgt. Goodman & Melissa Sies.

MINUTES: Mr. Waite made a motion to accept the September Minutes. Mr. Lehman seconded. Motion passed unanimously.

FINANCIAL: The September financial statement was reviewed along with the September reconciliations. After a review of the bills, Mr. Lehman made a motion to pay the bills. Mr. Kramer seconded. Motion passed unanimously.

CHIEF'S REPORT:

- 1) Clerk Sies has earned her Kentucky Master Municipal Clerk certification through the KLC. She is one of only 23 active clerks throughout the commonwealth to have earned this certification. Well done Clerk Sies!
- 2) The department presented an Active Threat FRC (Family Reunification Center) training to the staff of Kenton County School District on October 4 & 6 at Lakeside Christian Church.
- 3) The annual audit presentation will be in November.
- 4) Sgt. Goodman coordinated a Level III Active Threat Class for the faculty & staff of St. Pius X on October 13. Lt. Colonel Degenhardt instructed a Level III Active Threat Class for the faculty & staff of Villa Madonna Academy on October 14.

Crestview Hills – The regular meeting was October 13th – The city had a second reading of the Parks & Recreation Ordinance; a Resolution was presented approving the bid to construct an enhanced crosswalk on Thomas More Parkway; Trick-or-Treat hours are 6:00pm-8:00pm on October 31.

Lakeside Park – The regular meeting was October 10th – The city hired full-time Assistant Clerk/Treasurer, Teresa Bruck; Mayor Markgraf & Mr. Waite continue to work on the Z21 zoning committee; the construction on N. Ashbrook should be completed within 1.5 weeks; there was recently a water main break on Turkeyfoot Road.


